Notification

No. 1/1/62 — IC.

In exercise of the powers conferred by section 7 of the Citizenship Act, 1955 (57 of 1955), the Central Government hereby makes the following Order, namely:

1. This Order may be called the Goa, Daman and Diu (Citizenship) Order, 1962.

2. Every person who or either of whose parents or any of whose grand-parents was born before the twentieth day of December, 1961, in the territories now comprised in the Union territory of Goa, Daman and Diu shall be deemed to have become a citizen of India on that day:

Provided that any such person shall not be deemed to have become a Citizen of India as aforesaid if

within one month from the date of publication of this Order in the Official Gazette that person makes a declaration in writing to the Administrator of Goa, Daman and Diu or any other authority specified by him in this behalf that he chooses to retain the citizenship or nationality which he had immediately before the twentieth day of December, 1961:

Provided further that in the case of a child, the declaration under the preceding proviso of the father, or if he is dead, of the mother, or if both parents are dead, of the legal guardian shall determine the citizenship or nationality of such child if on the date of such declaration he is below eighteen years of age, but such child may, within six months after attaining the age of eighteen years, make a declaration in writing to the Administrator of Goa, Daman and Diu or any other authority specified by him in this behalf that he wishes to acquire Indian citizenship and shall thereupon become a citizen of India.

MILITARY GOVERNMENT GOA, DAMAN AND DIU

ORDER

In exercise of the powers conferred on me by the 1st Proviso to Paragraph 2 of the Goa, Daman and Diu (Citizenship) Order, 1962, I hereby specify the Senior Superintendent of Police, Panjim as the authority to receive declarations in writing about the retention of the Citizenship or Nationality.

2. By virtue of Paragraph 2 of the Order every person who or either of whose parents or any of his grand-parents was born before the 20th day of December 1961, in Goa shall be deemed to have become a citizen of India on that day. Any person who makes a declaration in writing to the Senior Superintendent of Police before the 28th April 1962 that he chooses to retain the citizenship or nationality which he had immediately before the 20th day of

No uso das faculdades que me são conferidas pela disposição 1.ª do § 2.º de «The Goa, Daman and Diu (Citizenship) Order, 1962», designo o Superintendente-Chefe da Polícia, Pangim, como autoridade para receber declarações, por escrito, referentes a retenção da cidadania ou nacionalidade.

2. — Por virtude do § 2.º da «Order» todo o indivíduo que, ou ainda aquele cujo pai ou mãe ou qualquer dos seus avós, tenha nascido antes de 20 de Dezembro de 1961, em Goa, será considerado como tendo-se tornado cidadão indiano desde esse dia. Qualquer pessoa que declare, por escrito, ao Superintendente-Chefe da Polícia antes de 28 de Abril de 1962 que deseja manter a cidadania ou nacionalidade que tinha imediatamente antes do dia 20 de

December, 1961 shall not be deemed to have become a citizen of India.

ORDER

In exercise of the powers conferred on me by paragraph 2 of the Goa, Daman and Diu Administration (Removal of Difficulties) Order, 1962 read with No. II of Article 109 of Constituição Política da República Portuguesa, I hereby repeal Decree-Law No. 35 558 dated 27th March, 1946 with immediate effect.

ORDER

In exercise of the powers conferred on me by Section 2 of the Goa, Daman and Diu (Administration) Removal of Difficulties Order, 1962, I hereby order that no procession shall be taken in any part of the following vilas or towns except under a licence obtained from the Station Officer for the purpose.

1. Town of Goa,
2. Town of Margão,
3. Town of Mapuça,
4. Town of Vasco da Gama,
5. Vila Ponda, and
6. Vila Bicholim.

2. The promoters or organisers of the procession shall apply in writing for licence at least 48 hours before the date on which the procession is to be taken out, specifying the purpose for which the procession is being taken out, the time and route of the procession. The promoters or organisers shall give their full name and addresses on the application.

3. It will be competent to the Station Officer concerned to specify the route and time for the procession.

4. The Senior Superintendent of Police or the Chief Civil Administrator may, without assigning any reasons therefor, cancel any licence granted by the Station Officer.

5. This order shall not apply to religious processions, funeral processions, wedding processions or to Government servants on duty or any other procession authorised by law.

6. This order comes into force with effect from 1st April, 1962.

2. Os promotores ou organizadores de cortejos deverão requerer a licença, por escrito, pelo menos 48 horas antes da data em que o cortejo deve ter lugar, especificando o fim com que o mesmo é organizado, a hora e o trajecto a percorrer. Os promotores ou os organizadores deverão indicar nos pedidos os seus nomes e endereços por extenso.

3. Competirá ao «Station Officer» respectivo especificar o trajecto e a hora para cortejo.

4. O Superintendente-Chefe da Polícia ou o Administrador Civil, Chefe, poderá, sem dar quaisquer razões, cancelar a licença dada pelo «Station Officer».

5. Este despacho não se aplicará a procissões religiosas, cortejos fúnebres ou de casamentos, aos funcionários do Governo em serviço ou a quaisquer outros cortejos autorizados por lei.

6. Este despacho entra em vigor a partir de 1 de Abril de 1962.
