#### CIRCULAR

The competent Revenue Authorities, while deciding partition applications issues "Public Notice" as per Order V Rule 20 of the Civil Procedure Code in the cases where the notices could not be served through the normal mode of service as prescribed in Rule 3 of the Goa Daman and Diu Land Revenue (Partition of Holding) Rules, 1969. In such cases, the current practice of issuing "Public Notice" as per the Civil Procedure Code while deciding partition cases is not in consonance with the laid down Rules and procedures, especially the practice of asking affidavits from public to issue such public notices.

As per the Rule 3 of the Goa Daman and Diu Land Revenue (Partition of Holding) Rules, 1969, the notice in Form "A", appended to the said Rule, shall be served in accordance with the provision of Section 173 of the Goa Land Revenue Code, 1968. The provisions of Rule 3(1) the Goa Daman and Diu Land Revenue (Partition of Holding) Rules, 1969 are reproduced below:

Rule 3(1) On receipt of the application, the Collector shall hear the applicant in person on any day of which due notice shall be given to the applicant or on any day to which hearing may be adjourned; and if after hearing the applicant, it appears to him that the case does not fall under rule 10, he shall cause to be served in accordance with the provisions of section 173, a notice in Form A appended to these rules on all the other co-holders requiring them to appear before him and state their objections, if any, on a day to be specified in the notice which shall not be less than thirty or more than sixty days from the date of the issue of the notice on each such co-holder.

Further the provisions of Section 173 of Land Revenue Code, as amended, provides for the mode of serving notice even for the cases where direct services of notices could not be made. The relevant provision of Section 173 is reproduced below:

Section 173 (1) Subject to the provisions of this Code, and the rules made thereunder every notice under this code may be served either by tendering or delivering a copy thereof, or sending such copy by post or electronically or in the manner as prescribed, to the person on whom it is to be served, or his authorised agent or, if service in the manner aforesaid cannot be made, by affixing or displaying a copy thereof at his last known place of residence or at some place of public resort in the village in which the land to which the notice relates is situated, or on such website as may be specified by the Government by a notification in the Official Gazette.

The Goa Daman and Diu Land Revenue (Partition of Holding) Rules, 1969, provides for the Form for Notice and Form for Proclamation. The notice and proclamation should be issued in the forms and manner as prescribed as per the Land Revenue Code and the said Rules. All the concerned Revenue Officers are hereby directed to strictly abide by the laid down procedure detailed as above.
